

2024 OCEANIA AREA CHAMPIONSHIPS SELECTION POLICY: 1 - 8 June; Suva, Fiji

1. SELECTION PHILOSOPHY

1.1 This Selection Policy is issued by Athletics New Zealand Inc. (“Athletics NZ”) and sets out the basis on which Athletics NZ will consider athletes for nomination to compete at the 2024 Oceania Area Championships (the “2024 OAC”)

1.2 The 2024 OAC is an Athletics NZ representative opportunity for New Zealand athletes to compete for New Zealand for the below purposes:

- a) Under 18: To provide a development opportunity for U18 (Youth) athletes to represent New Zealand in 2024; and
- b) Senior Representation: To provide an opportunity for athletes to represent New Zealand as a senior athlete in 2024; and
- c) Para Athletes: To provide a development opportunity for athletes to represent New Zealand as a senior Para athlete in 2024.

1.4 In addition, this year Athletics NZ may be using the 2024 OAC as an opportunity for some athletes identified by the Athletics NZ High Performance Director (“Athletics NZ HPD”) to qualify for the Paris 2024 Olympic Games. This means those athletes may be given priority in terms of selection for the 2024 OAC, thereby reducing the number of “spots” available for other athletes in senior grades.

1.5 The 2024 OAC is an athlete-funded competition and athletes seeking nomination in accordance with this Selection Policy will have to participate at no-cost to Athletics NZ (refer to clause 10).

2. SELECTION PANEL

2.1 The board of Athletics NZ (the “Athletics NZ Board”) has endorsed the following Selection Panel (the “Selectors”) to consider and select athletes for the 2024 OAC:

- a) Tony Rogers (Convenor)
- b) Rosie Robinson
- c) Sarah Cowley Ross

2.2 The Board reserves the right to replace any member of the Selectors at any time for any reason.

3. CONDITIONS OF SELECTION

3.1 As a condition of selection for the 2024 OAC, an athlete must:

- a) If wishing to be selected as a senior athlete, have achieved at least one Performance Standard (refer to clause 5) that is listed on the official Athletics NZ rankings website and that is achieved within the following Qualification Period; and

Categories / Events	Qualification Period
All individual events and relays	1 January 2023 – 17 March 2024

- b) Be a registered member of Athletics NZ; and
- c) Have submitted an Application for Selection Form and paid a \$260.50 Bond (refer to clause 10.6) by midnight 17 March; and
- d) Have competed at the Compulsory Selection Trial/s (refer to clause 6); and
- e) Have satisfied all Oceania Athletics Association eligibility, nationality, and participation requirements, including those set out in clause 4; and
- f) Be a New Zealand citizen with a New Zealand passport at the time of the 2024 OAC; and
- g) Enter into an athlete agreement with Athletics NZ (the “**Athlete Agreement**”)
Note: This agreement will be distributed upon selection; and
- h) Be and remain in “good standing” with Athletics NZ and at all times comply with all Athletics NZ and / or World Athletics codes of conduct and regulations and the terms and conditions of the Athlete Agreement and otherwise conduct themselves in a way that does not bring the sport or the team into disrepute; and
- i) Have completed the World Athletics Safeguarding Essential Training Course via the World Athletics e-learning platform; and
- j) Not have used or administered any substance which, if it had been detected as being present in the athlete’s body tissue or fluids, would have constituted doping or used any prohibited method or committed any other doping offence as defined in any applicable Athletics NZ or World Athletics anti-doping or related rules or regulations.
Note: Athletes should be aware that failure to comply with any of the requirements set out in clause 3.1 may render an athlete ineligible for selection.

Team Size

3.2 The indicative team size for the 2024 OAC is 120 athletes, inclusive of U18, Senior and Para athletes. Nothing in this Selection Policy obliges Athletics NZ to select a full contingent of athletes, regardless of the Oceania Athletics Association or the 2024 OAC entry requirements.

Relay Athletes

3.3 In order to be eligible for selection to compete at the 2024 OAC as a member of a relay team, each member of the relay team must comply with all of the requirements set out in clause 3.1.

3.4 Relay team members that have not met the performance standard for an Individual Event may be included in an Individual Event at the discretion of the 2024 OAC Team Leader, in consultation with the Athletics NZ team management, the athlete and their personal coach; provided, however, that the athlete has met the applicable OAA minimum entry standard.

Note: Athletics NZ intends to support multiple relay teams to the 2024 OAC. (refer to clause 7.4)

4. ENTRY REQUIREMENTS

Age Requirements

4.1 In order to be eligible to compete at the 2024 OAC, athletes must have reached a minimum age of 16 years by 31 December 2024.

Individual Events

4.2 Member Federations may enter a maximum of three (3) athletes per Individual Event.

Para Athletes

4.3 Para Athletes must hold a current and valid National Classification.

5. SELECTION CONSIDERATIONS

5.1 U18 athletes who have completed an Application for Selection Form may be selected to compete in Individual Events at the 2024 OAC

5.2 U18 Performance Standards have not been stipulated in this Selection Policy for the 2024 OAC. Rather, a balanced team that enables Athletics NZ representation across most events will be selected, (including relay events).

Note; The indicative U18 team size is between 20 and 40 athletes per gender.

5.2 Para athletes who have completed an Application for Selection Form may be selected to compete in Individual Events at the 2024 OAC.

5.3 A Para athlete seeking selection must achieve the following Performance Standard/s listed in appendix 2 during the Qualification Period.

Note: Oceania Athletics Association cannot secure accessible accommodation and/or transport for Para athletes who require this. Athletes who require accessible accommodation and/or transport are encouraged to consider attending the 2024 Australian Track and Field Championships as an alternative.

5.4 Senior athletes who have completed an Application for Selection Form may be selected to compete in Individual Events at the 2024 OAC.

5.5 An athlete seeking selection as a senior athlete must achieve the following Performance Standard/s listed in appendix 1 during the Qualification Period.

6. COMPULSORY SELECTION TRIALS

6.1 The following two competitions are the Compulsory Selection Trials for the 2024 OAC:

- a) 2024 Jennian Homes NZ Track and Field Championships in Wellington, 14-17 March; and
- b) Athletics NZ Senior, U20 and U18 Combined Events Championships in Dunedin, 17-18 February.

6.2 All athletes seeking selection for the 2024 OAC must have competed in the Compulsory Selection Trial/s in the event/s most relevant to the event/s in which they are seeking selection.

6.3 Dispensations will only be granted in exceptional circumstances, and will be at the sole discretion of the selectors. Applications for dispensation must be made to the [convenor](#) of selectors prior to midnight 13 March.

7. ADDITIONAL SELECTION CONSIDERATIONS

7.1 Notwithstanding the provisions outlined in this Selection Policy, the Selectors have an overriding discretion to select any eligible athlete for the 2024 OAC if they, in consultation with the Athletics NZ Team Leaders, believe it is in the best interests of Athletics NZ to do so.

7.2 In considering athletes for selection, the Selectors may consider any factor or combination of factors that they deem relevant to their decision whether to select an athlete for the 2024 OAC, including but not limited to the athlete's:

- a) Performance at the relevant Compulsory Trial/s;
- b) Competitive record against other athletes under consideration for selection in the same event;
- c) Domestic performance at 2024 World Athletics Continental Tour and Challenger Events;
- d) Commitment and focus on competing at the 2024 OAC, and/or
- e) History of performances at previous selected individual or team events.

7.3 In any decision regarding the selection of athletes for the 2024 OAC, the Selectors may, in their sole discretion, also consider any extenuating circumstances, including but not limited to:

- a) Injury or illness;
- b) Travel delays;
- c) Equipment failure;
- d) Bereavement or personal misfortune; and/or
- e) Any other factors reasonably considered by the selectors to constitute extenuating circumstances.

Relays at the 2024 OAC

7.4 Athletics NZ intends to support multiple relay teams to the 2024 OAC. Athletes who commit to a) participating in relays at the 2024 OAC, and b) who have participated in Athletics NZ and/or New Zealand Secondary Schools Athletics Association relay development opportunities may receive priority selection.

2024 OAC Senior Selections

7.5 Athletics NZ can enter up to three athletes in each event. All athletes must meet the conditions of selection, (clause 3), to be eligible for selection.

7.6 In order to balance the selection of senior and U20 athletes, selections will be considered on the following basis.

- a) Any Senior athlete that wins a senior event at the Compulsory Selection Trial/s and has achieved an Athletics NZ "A" Performance Standard, in that event, will be given priority consideration for selection by the Selectors for the 2024 OAC, for that individual event, provided those athletes meet the conditions of selection, (clause 3), to be eligible for selection.
- b) Alongside this, any U20 athlete that wins an U20 event at the Compulsory Selection Trial/s, and has achieved an Athletics NZ "B" Performance Standard, in that event, will be given priority consideration for selection by the Selectors for the 2024 OAC, for that individual event, provided those athletes meet the conditions of selection, (clause 3), to be eligible for selection.
- c) For a third competitor to be eligible for selection in any individual event, that individual must have achieved an Athletics NZ "B" Performance Standard.
- d) In events where no eligible athlete is selected using the above considerations, the Selectors may select any eligible athlete who has achieved an Athletics NZ "B" Performance Standard.

2024 OAC U18 Selections

7.7 U18 athletes that place first or second in an U18 event at the Compulsory Selection Trial/s will be given priority consideration for selection by the Selectors for the 2024 OAC, for that individual event, provided those athletes meet the conditions of selection, (clause 3), to be eligible for selection.

7.8 In addition to the factors outlined in clause 7.2, the Selectors may consider any combination of factors that they deem relevant to their decision whether or not to nominate an U18 athlete, including but not limited to the athlete's:

- a) Ability and willingness to compete in multiple events at the 2024 OAC;
- b) A spread of athletes across different event groups, e.g. Sprints / Hurdles, Distance, Jumps, Throws, Combined events, Relays;
- c) Quality and consistency of performances during the Qualification Period.

8. SELECTION PROCESS

8.1 Athletics NZ will select Individual(s) and/or Team(s) in accordance with the criteria set out in this Selection Policy and as allowed by the 2024 OAC Technical Regulations and the LOC Entry Requirements.

Ratification Review

8.2 The Athletics NZ Board must ratify selections prior to the Selection Announcement.

Selection Announcements

8.3 The Selection Announcement of the athletes selected for the 2024 OAC will be published on the Athletics NZ website by 5pm 1 April 2024 (the "Selection Announcement").

8.4 The Selectors and the Athletics NZ Board reserve the right to add additional athletes to the team after the date of the Selection Announcement on terms and conditions set by the Selectors (as approved by the Athletics NZ Board).

9. NON-SELECTION QUERIES &/OR APPEALS PROCESS

9.1 Non-selected athletes can query their non-selection after the Selection Announcement by contacting Athletics NZ (i.e., to seek clarification regarding their non-selection).

Non-selection appeals process

9.2 The publishing of the Selection Announcement on Athletics NZ website will be deemed to be the commencement of the 48-hour period to lodge non-selection appeals in accordance with this Selection Policy.

9.3 Any athlete whose selection is not ratified by the Athletics NZ Board in accordance with this Selection Policy may appeal their non-selection providing they:

- a) Have completed and submitted an Application for Selection Form to Athletics NZ in accordance with the timelines contained in this Selection Policy; and
- b) Submit a notice of their intention to appeal their non-selection in writing to the CEO of Athletics NZ (Cameron Mitchell) within 48 hours of the decision of the Board being published on the Athletics NZ website.

9.4 If an initial non-selection appeal to Athletics NZ is unsuccessful, athletes have the right to further appeal to the Sports Tribunal under its Rules and the grounds for an appeal will be as set out in those Rules. This provision will apply in relation to non-nomination/selection appeals. General provisions relating to appeals in the Constitution and By-Laws of Athletics NZ will not apply.

10. GENERAL INFORMATION

10.1 This Selection Policy may be amended at any time prior to the Selection Announcement by the Athletics NZ Board. Any amendment will be published on the Athletics NZ website.

Funding

10.2 The 2024 OAC is an athlete-funded competition and athletes seeking selection in accordance with this Selection Policy will have to participate at no-cost to Athletics NZ.

10.3 Athletes considering competing at the 2024 OAC should plan their funding and budgets early. The trip cost is estimated to be between \$3,500 - \$5,000 NZD per athlete.

10.4 A management levy will be charged across all athletes (i.e., above the cost of their own travel and accommodation) to assist with the cost of the 2024 OAC Team Leaders and/or support staff/volunteers.

10.5 For athlete-funded competitions, three (3) weeks prior to the departure of the team from New Zealand all athlete-funding components must be paid in full to Athletics NZ.

Note: Non-payment of the athlete-funding components in full by this date will result in removal of the athlete from the team and the withdrawal of that athlete's entry in the 2024 OAC. Unpaid amounts will remain outstanding and will be subject to collection in accordance with Athletics NZ Debtors policy.

Bond

10.6 Athletes seeking selection for the 2024 OAC will be required to pay a Bond of \$260.50 along with their Application for Selection Form by midnight Sunday 17 March, 2024.

10.7 The conditions associated with the Bond are:

a) The Bond is payable when completing the application for selection form online.

Refund of Bond

b) The full amount of the Bond paid will be refunded (less processing fees of \$10.50) if an athlete is not selected;

c) Any refund is subject to the athlete in question having included details for the refund payment (i.e., bank account details or address and payee for refund) in their Athlete Application. Refunds cannot be made without these details;

d) If an athlete withdraws from the team after selection for any reason, there will be no refund of the bond available. Athletes should be aware that late withdrawal may result in them being required to pay an additional amount in excess of the \$260.50 bond should Athletics NZ's unrecoverable costs be in excess of that amount.

Application of Bond

e) If selected \$250 of the Bond will be applied by Athletics NZ to offset costs payable by that selected athlete as a member of the 2024 OAC team (i.e., it is not an "extra" fee/levy).

Team Managers/Coach/Staff Appointments

10.8 It is anticipated that at least eight volunteer team managers and coaches will be required to support the 2024 OAC team. Information for members of the Athletics Community interested in these roles will be posted to the Athletics NZ website in February 2024.

10.9 In some instances, when there is a need for an Athletics NZ staff member to fill a team management position, at the discretion of Athletics NZ and approval of the Athletics NZ CEO, team management appointments may not be advertised.
