Acceptable Forms of ID

The list of acceptable forms of ID to be sighted (originals only, not photocopies), one **Primary** and one **Secondary**, one of which must be photographic are:

Primary IDs:

- Passport (NZ or Overseas)
- NZ Firearms Licence
- NZ Full Birth Certificate if issued after 1st January 1998 and carrying a unique identification number
- NZ Citizenship Certificate
- NZ Refugee Travel Document
- NZ Emergency Travel Document
- NZ Certificate of Identity

Secondary IDs:

- NZ Drivers Licence
- 18+ card
- NZ Full Birth Certificate
- Community Services card
- SuperGold Card
- NZ Employee Photo ID Card
- NZ Student Photo ID Card
- Inland Revenue number
- NZ issues utility bill (not more than 6months old at time of sighting)
- NZ Teachers Registration Certificate
- NZ Electoral Roll Record
- International Driving Permit
- Steps to Freedom Form

Note that the Police Vetting Authority prefer current documents, however, documents that have expired within the past five years may be accepted.
